

SUPPLY & DELIVERY

- 1. Taylor Preston Ltd/CR Grace Ltd will determine delivery dates for contracted product on a weekly basis and advise supplier accordingly. Taylor Preston Ltd/CR Grace Ltd reserves the right to alter delivery dates at any time.
- The lambs on this contract are for the European chilled trade. Hygiene requirements in EU contracts require that your lambs are presented dagged and also crutched and bellied if wool is longer than 50mm. <u>Livestock must be off green feed for 4-12 hours</u>. A charge of \$0.50/kg will be made on sheep that do not comply with these requirements.
- Minimum volume commitment 100 lambs per line.
 Each week will be filled on a first in first served basis.
- 4. Transport to be CR Grace Ltd responsibility. (Note: Some conditions may apply).

PAYMENT TERMS - 7 working days after slaughter date

CONTRACT TERMS

- 1. The price is **<u>\$5.50 \$6.00 per kilo</u>**. Less levies/includes short wool premium. There is no supply premium over and above the fixed contract price.
- 2. Contract period is 16th August 2015 14th November 2015 (12 weeks).
- 3. Specifications of the contract are for all PYT Lamb Grades weighing between <u>14.5 to 24.9 kg</u>. Any lambs supplied that weigh over 24.9kg will be discounted by \$1.00 per kg and all other weights and grades will be paid at the schedule of the week.
- 4. If you fail to supply at least 95% of the number of contracted lambs, then you agree to pay to Taylor Preston Ltd/CR Grace Ltd by way of liquidated damages the sum of \$20 per lamb for each lamb you fail to supply, measured against the 95% minimum volume and that Taylor Preston Ltd/CR Grace Ltd may deduct that amount from any payment otherwise due to you, or send you an invoice for any monies outstanding.
- 5. All lambs supplied over and above the contracted amount will be priced at schedule on the date of kill.
- 6. If commitment supply clients choose to participate in the contract, the contract lambs count towards your volume commitment but don't attract any additional headage payments.
- This contract is to be completed, <u>signed & returned to a CR Grace Ltd Buyer by 5pm 24th July 2015</u>. No verbal commitments will be accepted. This contract does not come into force until you have received a countersigned copy and confirmation from CR Grace Head Office as verification of your contract.
- 8. This contract is for a limited number of lambs and could well be filled before the closure date. Taylor Preston/CR Grace reserves the right to close or extend this contract at any time.
